Britt David Road, Columbus, Georgia 31909-5399. Bids not in the possession of the Commission at bid closing will be returned unopened. Submittals shall be in clearly marked in a sealed envelope, and shall include one signed original and one copy.

SCOPE OF WORK:

The base bid work is generally described as bituminous pavement crack repair on Taxiway D and adjacent connector taxiways. This work includes crack cleaning and sealing, and provision of new painted markings. Performance of the work shall occur in specified phases, including limited night work, to mitigate impacts to air operations on Runway 6-24.

A **PRE-BID CONFERENCE** for this project will be held on **Wednesday**, **January 03**, **2018** at <u>1:30 P.M.</u> (local time) at the 2nd Floor Conference Room, Columbus Airport Commission, Columbus Airport, 3250 W. The Pre-Bid Conference will be the only opportunity for bidders to examine the site.

Bid security in the amount of five percent (5%) of the base bid will be required to accompany bids. Contract Bonding shall also be required. The Owner reserves the right to reject any or all bids and to waive irregularities in bidding, and to award in the best interests of the Owner. Participation in the Owner's Disadvantaged Business Enterprise (DBE) Program is required. The DBE goal for this contract is **9.5 percent.** Firms certified as DBE by the Georgia Department of Transportation shall be considered toward the goal.

This project will be bid as a single contract. Bid prices must be held for up to 60 days.
