1.	Badging. Is security badging required for the airport?

2. Resident Engineer. We want to confirm that the commission will require a resident engineer will be required for this project (per B. Description of Work D.7)?

As stated in the reference a "resident engineer, inspector or manager will be required". One of the three will be expected based on direction from or recommendations to the Commission.

3. Survey and Geotechnical work. Is there any aspect of the SOW that will require either a survey or geotechnical work? The Project Scope describe in Appendix A is limited to work either inside or around the building. With the exception of landscaping at the curbside, there is no work stated for site work.

As of the time of the issuing of the SOQ, survey or geotechincal work had not been anticipated.

4. Existing drawings. Are there any existing drawings available of the terminal building – architectural, building systems (mechanical, plumbing, fire protection, electrical and telecommunications)?

Drawings for the terminal do exist but have been deemed somewhat unreliable due to the passage of time and undocumented maintenance to the facility.

5. Main Terminal building size. Is there any information available on the total square feet, or square feet per floor, of the main terminal?

The first-floor square footage is approximately 48,500. The second-floor square footage is 23,900 with approximately 6,800 being part of the project.
